The Committee of Credentials and Licenses suggested that a statement be recorded clearly setting forth procedures for the granting of self-employed status and parsonage allowance privileges to ordained ministers holding current ministerial credentials. The matter was discussed, and it was

Agreed, To recommend to PRADCO that 1. When a member of the General Conference staff is recommended for ordination and subsequently issued ministerial credentials he immediately be considered eligible to self-employment status and eligible for parsonage allowance privilege.

2. Ordained ministers on the General Conference staff who hold current ministerial credentials from the General Conference shall be considered eligible to self-employed status and eligible for the parsonage allowance privilege.

## LICENSED MINISTERS

RHP/NCW

Internal Revenue Service has taken the position that Seventh-day Adventist licensed ministers cannot be considered as ministers of the Gospel, and therefore should be treated as "employees." We have consistently taken the position that licensed ministers should be treated as ministers of the Gospel, and have authorized legal action to determine the validity of the IRS position. However, growing out of the three-and-one-half-day meeting (June 24-27, 1976) on Church, State and Labor Unions was the suggestion there might be a better way to handle the licensed ministers' problem than legal action.

A study by a subcommittee of the special "Church, State and Labor Unions" Committee concluded that in the light of the Church's position that it will cooperate with the government in those areas that do not threaten its life and mission we ought to re-examine the position we have taken on the licensed minister. This study led to the presentation of a document which would change the responsibility of the licensed minister in those cases where the minister had completed the required ministerial training course in the Seventh-day Adventist Church authorizing him on a probationary basis to perform all of the functions of an ordained minister under the supervision of his ecclesiastical superior.

Agreed, To ask the Presidential staff to study the suggestions for changing the authority of the licensed minister. (C E Bradford and N R Dower were present for the discussion of this item.)

# (X-1845) LICENSED MINISTERS

On June 29, 1976, PREXAD studied the question of the licensed minister and his relationship to Internal Revenue and asked that further study be given to the possibility of adjusting the authority of the licensed minister so that he would be considered as a gospel minister under the definition of Internal Revenue.

Neal Wilson presented a proposal prepared by the NEID Union Presidents at their recent meeting which was discussed and it was

# <u>Agreed</u>, To recommend the following to PRADCO:

- (1) A person is recognized as a minister of the gospel in the Seventh-day Adventist Church when he has met all the following prerequisites:
- a. Completion of the prescribed ministerial education training requisites of the Seventh-day Adventist Church as defined

by the division committee for his territory.

- b. Appointed to a ministerial or pastoral responsibility.
- c. Issued a ministerial license.
- d. Ordained as a church elder.
- (2) He is authorized by the Conference Executive Committee to perform all the functions of the ordained minister in the church or churches where he is assigned.
- (3) The authorization to serve as a minister of the gospel and to perform all the functions of an ordained minister may, on recommendation of

his ecclesiastical superior, be withdrawn by the Conference/Mission Executive Committee.

- (4) His leadership progress, his professional development and his spiritual growth will be reviewed annually by the conference administration and Executive Committee.
- (5) Ordinarily after a probationary or training period (normally about four years) a licensed minister is ordained. This spiritual rite constitutes the official confirmation by the Seventh-day Adventist Church of one's divine call to the ministry as a life commitment, and is his endorsement to serve as a minister of the gospel in any part of the world.

## ROLE OF WOMEN SURVEY

Approximately 1,000 church members were surveyed with this number being about equally divided between men and women. The survey was conducted in such a way that there could also be an indication as to the attitude of different age groups, laymen, and denominational workers in three or four different categories,

## A 1548 ROLE OF WOMEN SURVEY - SUBCOMMITTEE REPORT

On January 3, 1978, PREXAD appointed a subcommittee to give study

as to how to use the results of the Role of Women survey conducted by Don Yost. The committee report indicates that although the main question has occupied a great deal of time and attention on the part of several church organizations in recent months it appears that within the Seventh-day Adventist Church interest and agitation on this subject are diminishing. As the result of a secret ballot vote in one large Seventh-day Adventist Church within recent weeks, it was decided to drop the subject for the present. In the light of these present circumstances it was

Agreed, 1. To file the survey report on the Role of Women as local church elders and ministers for the present since it was prepared for the information of the General Conference administration.

- 2. To request A Lohne and C 0 Franz to edit the report, removing from it any assumptions, but leaving intact the factual and statistical portions.
- 3. To authorize the release of the amended report to division presidents and NAD union presidents with the understanding that it is not for general circulation.

# LADY PASTORS AND PASTORAL ASSOCIATES

Counsel has been sought on the question of associates in pastoral care performing baptisms. It was pointed out that in establishing the position of associates in pastoral care it was understood that such individuals were not in line for ordination. The Church Manual, however, does provide for local church elders to baptize under certain unusual conditions, and that if those conditions obtained the associate in pastoral care who is also a local elder should be dealt with by the conference in the same way that other local church elders are dealt with in this matter.
